Please ensure your application includes:

- Copy of SSAA Membership card or receipt for SSAA membership
- Copy of your Safety course certificate if you have completed it (don't include original!)
- Copy of your photo ID (eg. driver license) & Handgun Licence.
- Copy of the certificate and participation pages from the back of your Introduction to Handguns book, showing completion of the course and at least two participations.
- Passport style photo (used for your SSPC membership card, please print your name on the back of your photo.)
- Completed application form
- Payment for membership (complete payment details on form)

Do Not Print Double Sided, Do Not Staple & Submit only in A4 Envelope.

Applications for membership are considered at each committee meeting, generally held on the 4th Wednesday of each month. Please ensure that you have your application in to us by the **Wednesday before** the committee meeting.
